"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, being shown on a plat of Property of Roy Cunningham and Mamie Cunningham, prepared by Terry T. Dill, R.L.S., dated April 9, 1965, recorded in the RMC Office of the Greenville County Courthouse in Plat Book III at page 104 and having, according to said plat, the following metes and bounds, to-wit:
