All that piece, parcel or lot of land, with the buildings and improvements thereon, situate lying and being in the city of Greenville, County of Greenville, State of South Carolina, being known and designedated as Lot No. 50 and the assjointing one-half of Lot 51. Pleasnat Valley Subdividion, ass per plat theref recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "BB", Page 163, and having, according to the said plat, the following Metes and Bounds, to Wit:
