"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE

All that piece, percel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the north side of Dolphin Street and being known and designated as Lot No. 27, Section 3, of Greenfields as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book "GG", at Page 93 and having, according to said plat, the following metes and bounds, to-wit:

BECIMING at an iron pin on the north side of Dolphin Street at the joint front corner of Lots Mos. 27 and 28 and running thence along the joint line of said lots M. 37-42 E. 174.4 feet to an iron pin; thence N. 17-35 W. 48 feet to an iron pin; thence S. 74-15 W. 234 feet to an iron pin; thence S. 35-45 E. 143.6 feet to an iron pin on the morth side of Bolphin Street; thence along the curve of Dolphin Street, the chord being S. 88-58 E., 60 feet to the point of beginning.
