conditions), said note to be repaid with interest as the rate or rates therein specified in installments of ... One Hundred Thirty-

eight and 10/100 ------(\$138.10 -----) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not some paid, to be due and payable --14--- years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL those pieces, parcels or lots of land situate, lying and being on the eastern side of Old Easley Bridge Road and the western side of Old Dunham Bridge Road near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 3, a major portion of Lot No. 2 and a small portion of Lot No. 1 of a plat of a subdivision of property of Arthur Phillips, Estate which plat is recorded in the R.M.C. Office for Greenville County in Plat Book S at Page 97 A and according to said plat has the following metes and bounds, to-wit:

BECINNING at an iron pin on the eastern side of Old Easley Bridge Road at the joint corner of Lots Nos. 3 and 4 and running thence with the joint line of said lots S. 63-27 E., 259.5 feet to an iron pin on the western side of Old Dunham Bridge Road; running thence with the western side of said road N. 26-33 E., 147.4 feet to an iron pin in the front lot line of Lot No. 2; running thence along a new line N. 81-11 W., 36.3 feet to an iron pin; running thence N. 39-59 W., 120 feet to an iron pin in the line of Lot No. 1 and on the eastern side of Old Easley Bridge Road; running thence with the eastern side of said road S. 48-43 W., 246.3 feet to an iron pin, point of beginning.
