

Office for Greenville County, South Carolina, in Plat Book A, Page 179, and being more particularly described according to said plat as follows:

BEGINNING at the southeastern intersection of Pettigru Street and Toy Street, and running thence along Toy Street, S. 15-00 E., 126 feet 1 inch to a ten foot alley; thence N. 76-45 E., 73 feet 4 inches along said ten foot alley; thence N. 15-00 W., 126 feet 1 inch to Pettigru Street; thence along Pettigru Street, S. 76-45 W., 73 feet 4 inches to the beginning corner.
