NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, Cleveland Township, containing 10.3 acres according to a Survey thereof made by Terry T. Dill on December 3, 1958 of a portion of the S. C. Beattie Estate and having the following metes and bounds according to said plat:

BEGINNING at an iron pin in the center of the Middle Saluda River and running thence South 74-30 West 1018 feet to an iron pin; running thence South 56-20 East 938.4 feet to an iron pin in center of Road; running thence with said Road, North 39-04 East 367 feet to a nail on surface of road; running thence North 10-00 East 300 feet to an iron pin at edge of said road; running thence North 76-15 East 72 feet to the center of Middle Saluda River; running thence with the center of the river as the line, North 36-30 West 250 feet to an iron pin, the beginning corner.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomspever fawfully claiming the same or any part thereof.
