ALL that lot of land in the County of Greenville, State of South Carolina, being a portion of Lots Nos. 1 & 2, Sec. A of Oak Hill subdivison recorded in plat book MM, page 29 of the RMC Office for Greenville County, S.C., and having according to said plat and a recent survey made by Campbell & Clarkson, Surveyors, Inc., RLS, the following metes and bounds, courses and distances, to-wit:

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:
