NOW KNOW ALL MEN, that in consideration of said loan and to further secure the payment of said Note and also in consideration of three dollars (\$3) to the Mortgagors in hand well and truly paid by Mortgagee at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, the Mortgagors hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate, situated in the County of Greenville and State of South Carolina, to wit: BEGINNING at an iron pin being the joint front corner of Tract No. 1 and the property of Ed Koseley, and running thence S. 23-15 E. 680 Feet to an iron pin on the line of the Robert McDaniel property, thence N. 23-30 E. 85 Feet to an iron pin; thence N. 28.00 W. 627 Feet to an iron pin on an unnamed country Road., thence S. 61-30 ". 67 Feet to the point of beginning, said measurement extending beyond iron pins to the center of the unnamed county. To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above-described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue.
