MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Carl Stevens Hinson

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Twenty Thousand Four Hundred Fifty and No/100-----(\$ 20,450.00--)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith which note does not provide a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of One Hundred

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may be reafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose.

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 66 on a plat of Points North made by R. B. Bruce, Registered Surveyor, on November 22, 1972, and recorded in the R.M.C. Office for Greenville County in Plat Book 4X at Page 16, and being more particularly described as follows:

BEGINNING at an iron pin on Colony Road at the joint front corner of Lots 65 and 66 and running thence along the joint line of said lots N. 49-28 E. 150 feet to an iron pin at corner of Lots 64, 65, 66 and 73; thence with the line of Lots 73 and 72 N. 39-08 E. 115 feet to an iron pin at the corner of Lot 67; thence with the line of Lot No. 67 S. 49-28 W. 150 feet to an iron pin on Colony Road; thence with said road S. 40-32 E. 115 feet to the point of beginning.

This being the same property conveyed to the grantors herein by deed of Points North Development Company, said deed being recorded in the R.M.C. Office for Greenville County in Deed Book 981 at Page 679.

The property above described is conveyed subject to all easements, rights-of-way and restrictions of record, including those recorded in Deed Book 971 at Page 441.
