"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown on plat of survey for William Rex Howard, prepared by Carolina Surveying Company, dated March 9, 1974, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a point on the Easterly side of Scuffletown Road and running thence with the Easterly side of said road, N. 5-40 W., 311.1 feet to a point in line of Howard; thence with old branch run as the line, the meanders of which are N. 87-18 E., 679 feet to a point in creek; thence with the creek as the line, the meanders of which are S. 22-06 W., 155.1 feet to a point; thence S. 68-02 W., 87.6 feet to a point; thence S. 73-23 W., 220 feet to a point; thence S. 66-51 W., 160.7 feet to a point; thence S. 73-59 W., 155.5 feet to the beginning corner.
