WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indicated to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose,

NOW KNOW ALL MEX. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor's necount, and also in consideration of the sum of Three Dollars (\$5,00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargainesd, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of Irial, with all improvements thereon, or bereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lot No. 48 of a subdivision known as Knollwood according to a plat thereof prepared by Pickell & Pickell, Engineers, May, 1953 and recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 35, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of Meyers Drive at the joint front corner of Lots 48 and 49, and running thence along the joint line of said lots, S. 62-58 E. 289.5 feet to an iron pin at the joint rear corner of said lots; thence S. 9-33 W. 92.1 feet to an iron pin at the joint rear corner of Lots 47 and 48; thence along the joint line of said lots, N. 62-58 W. 317 feet to an iron pin at the joint front corner of said lots on the southeast side of Meyers Drive; thence along the southeast side of Meyers Drive, N. 27-02 E. 88 feet to the beginning corner; being the same conveyed to Charles Randal Shelton and Janice Neill Shelton by Glendon T. Nicholas and Gertrude C. Nicholas by deed dated April 15, 1969 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 866, at Page 146, the said Charles Randal Shelton having conveyed his undivided interest in said property to the mortgagor by deed dated May 3, 1973 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 973, at Page 815.

This is a second mortgage and is junior in lien to that mortgage executed to the First Federal Savings and Loan Association of Greenville, which mortgage is recorded in the R. M. C. Office for Greenville County in Mortgage Book 1118, at Page 627.
