BEGINNING at an iron pin on the South side of East Prentiss Avenue, joint corner Lots 14 and 15; thence S. 33-36 W. 170 feet to an iron pin on an unnamed 15 foot alley; thence S. 56-28 E. 60 feet to an iron pin at the intersection of said unnamed 15 foot alley with another unnamed street or alley; thence N. 34-01 E. 163.5 feet to an iron pin on the South side of E. Prentiss Avenue; thence with said avenue N. 50-20 W. 61.5 feet to beginning.
