NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (S3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville

State of South Carolina: on the Eastern side of West Castle Road, being shown and designated as Lot 158 on a plat of PINE HILL VILLAGE recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ, at Page 168, reference to said plat being craved for a complete and detailed description thereof. Sait Lot fronts 80 feet on the Eastern side of West Castle Road, runs to a depth of 107.3 feet on its Northern boundary; runs to a depth of 116.1 feet on its Southern boundary; and is 80.5 feet across the rear.

The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment.
