which this mortgage secures.


with interest thereon from **date** at the rate of **Six (6%)** per centum per annum, to be paid **monthly**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums to which the Mortgagor may be liable to the Mortgagation, for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars \$3.00 to the Mortgagor in hand well and truly paid by the Mortgagor at and before the setting and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the Mortgagor his successors and assigns,

"M.L. that certain place, parcel or lot of land, with all its improvements thereon, or hereafter constructed thereon, private, lying and being in the State of South Carolina, County of Greenville and according to a plat prepared of said property by J. Mac Richardson, June, 1960, having the following courses and distances to-wit:

BEGINNING at a point in or near the center of Ridge Road, joint front corners with Lot 33, Franklin Estates Properties and running thence with said line, S. 65-00 W. 217 feet to an iron pin; thence, N. 22-35 E. 133.6 feet to an iron pin; thence, N. 20-12 E. 50 feet to an iron pin; thence, N. 43-11 E. 52 feet to an iron pin; thence, N. 69-45 E. 77 feet to a point in or near the center of Ridge Road; thence running with said road, S. 5-04 E. 140 feet to a point in said road, the point of beginning.
