That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three D hars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, solid and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on South Carolina Highway No. 106, being shown and designated as Lot No. 4 on plat of Section II of Belle Terre Acres, prepared by C. G. Riddle, July, 1964, and revised October. 1965, containing 2.16 acres, more or less, and having, according to said plat, the following metes and bounds, to-wit:

BEHINNING at an iron pin in the center line of South Carolina Highway No. 106 at the joint front corner of Lots Nos. 4 init and running thence S. 30-34 E. 377.5 feet to an iron pin: thence S. 26-46 E. 377.5 feet to an iron pin: thence along the line of Lot No. 5 N. 7-40 E. 364 feet to the center line of South Carolina Highway No. 106; thence with the center line of sain Highway N. 75-47 W. 101 feet to a point; thence still with said Highway N. 76-31 W. 105.6 feet to the point of beginning.
