NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Whitestone Avenue, being shown and designated as Lot 4 on a plat of Adams Mill Estates, prepared by Dalton & Neves, Engineers, dated July, 1972 and recorded in the R.M.C. Office of the Greenville County Courthouse in Plat Book 4-R at page 31 and being described, according to said plat, more particularly, to-wit:

BEGINNING at an iron pin on the northern side of Whitestone Avenue at the joint front corner of Lots 3 and 4 and running thence along Whitestone Avenue, N 55-13 W 100 feet to an iron pin at the joint front corner of Lots 4 and 5; thence along the common line of said Lots, N 34-47 E 160 feet to an iron pin at the joint rear corner of said Lots; thence along the rear line of Lot No. 4, S 55-13 E 100 feet to an iron pin at the joint rear corner of Lots 3 and 4; thence along the common line of said Lots, S 34-47 W 160 feet to an iron pin, the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1/3 of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's Amount and collect it as part of the debt secured by the mortgage.

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgage may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagor agrees to pay to the mortgagee as premium for such insurance one half of 1% of the principal balance then Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or existing, in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fix tures and equipment, other than the usual household furniture, be considered a part of the real estate.
