MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Charles L. Elliot, Jr.,

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND JOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagoe) in the full and just sum of Seventeen Thousand

Five Hundred and No/100----- (\$17,500.00 ...)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not provide a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of One Hundred Forty

and 81/100-----(5 140.81) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable. years after date, and

WHEBEAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and impublifier a period of thirty days, or if there shall be any failure to comply with and abole by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgague may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgague's account for the payment of taxes, insurance premiums, repairs, or for any other purpose,

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgages to the Mortgages's account, and also in consideration of the sum of Three Dollars (53,000) to the Mortgages in hard well and truly publish the Mortgages at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and release into the Mortgages, its successors and assigns, the following described real estate.

All that vertain piece, parcel, or lot of land, with all improsyments thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, State of South Carolina, shown and designated as Lot No. 133, on plat of SECTION NO. 2 BELLINGHAM, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "4-N", at Page 79, with the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Brookmere Road at the joint front corner of Lots Nos. 132 and 133, and running thence with the line of said lot, N 18-43 E 150 feet to an iron pin; running thence \$ 71-17 E 80 feet to an iron pin; running thence with the said line of Lots Nos. 133 and 134 S 18-43 W 150 feet to iron pin on northerly side of Brookmere Road; thence with the northerly side of Brookmere Road N 71-17 W 80 feet to the point of beginning.
