NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 42 on plat of White Oak Subdivision of Northside Development Company, made by J. D. Pellett, Jr., Engineer, August, 1946, recorded in the RMC Office for Greenville County in Plat Book P at Pages 120 and 121, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Vanderbilt Circle, which point is S. 74-34 W. III.3 feet from the northwest corner of the intersection of Holmes Drive and Vanderbilt Circle, and is the joint front corner of Lots 41 and 42, and running thence with the line of Lot 41, N. 17-55 W. 140.7 feet to an iron pin; thence N. 53-45 W. 62.6 feet to an iron pin; thence S. 63-29 W. 47.7 feet to an iron pin; thence with the line of Lot 43, S. 39-11 E. 193.1 feet to an iron pin on the north side of Vanderbilt Circle; thence along the north side of Vanderbilt Circle N. 67-07 E. 80 feet to the beginning corner.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the term hereof of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's amount and collect it as part of the debt secured by the mortgage.

The mortgagors agree to maintain guaranty insurance in force until the loan balance reaches 75% or less of the original appraisal or sales price, whichever is less, and the mortgagee may apply for mortgage guaranty insurance to comply with the above, through the mortgage guaranty insurance company insuring this loan, and that the mortgagor agrees to pay to the mortgagee, annually, as premium for such insurance 1/4 of 1% of the principal balance then existing.
