
Carl E. Crawford and Jeanette E. Crawford----- of  
Greenville, South Carolina-----, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Cameron-Brown Company-----

-----, a corporation organized and existing under the laws of Raleigh, North Carolina-----, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Six Thousand Eight Hundred and No/100----- Dollars (\$6,800.00-----), with interest from date at the rate of Eight and three-fourths----- per centum (8 3/4-----) per annum until paid, said principal and interest being payable at the office of Cameron-Brown Company----- in Raleigh, North Carolina----- or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty-eight and No/100----- Dollars (\$68.00-----), commencing on the first day of August, 1974, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of July, 1989.

NOT, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville-----, State of South Carolina:

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, in the County of Greenville, near the City of Greenville, on Gentry Street, being shown and designated as Lot No. 36 of Pendleton Heights Subdivision on a plat recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book E at Page 72, and reference to said plat is craved for a metes and bounds description.



Together with all and singular the rights, members, tenements, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits, which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances, whatsoever. The Mortgagee further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1 That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal first due next due on the note, on the first day of any month prior to maturity, or any day thereafter, but in no event shall the interest to be satisfied by such payments be given at least thirty days prior to payment, and in no event shall the debt be paid in full prior to maturity, and
