All that certain piece, parcel, or lot of lind with all improvements thereon, or hereafter to be constructed thereon, situate, bying and being in the State of South Carolina, County of GREENVILLE, being known and designated as Lot 83 on a Plat of Dovetree, Sheet 2 of 3, prepared by Piedmont Engineers and Architects, dated September 18, 1972, and recorded in the R.M.C.
