\$51.00 on the 15th day of each and every month hereafter, commencing August 15, 1974; payments to be applied first to interest, balance to principal, balance due five (5) years from date, with the privilege to anticipate payment at any time,

with interest thereon from date at the rate of eight (8%) per centum per annum, to be paid: MONTHIY

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgigee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, on the northeastern side of Somerset Avenue (formerly East King Street) and being known and designated as Lot No. 94 of Anderson Street Highlands as shown on a plat thereof prepared by Dalton & Neves dated 1939, and recorded in the R.M.C. Office for Greenville County in Plat Book "J", at Page 157 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Somerset Avenue, joint front corner of Lots 93 and 94 and running thence along said Avenue, N. 47-20 W. 50 feet to an iron pin, joint front corner of Lots Nos. 94 and 95; thence along the joint side line of said lots, N. 42-40 E. 150 feet to an iron pin, joint rear corner of said lots; thence S. 47-20 E. 50 feet to an iron pin, joint rear corner of Lots Nos. 93 and 94; thence along the joint side line of said lots S. 42-40 W. 150 feet to the point of beginning.



Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagre, its heirs, successors and assigns, forever.

The Mortgague covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgager further covenants to warrant and forever defend all and singular the said premises unto the Mortgages forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgigor further covenints and agrees as follows.

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of tieres, murrance premiums, public assessments, repairs of other purposes pursuant to the covenints berein. This mortgage shall also secure the Mortgagee for any further loans, advances, rendvances or credits that may be made hereafter to the Mortgagee by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
