1) ALL that certain piece, parcel and lot of land situate, lying and being at the southeastern corner of the intersection of Pettigru Street and Williams Street in the City of Greenville, State of South Carolina, and being known and designated as Lot No. 1 on a plat of "Property of Thomas F. Parker", prepared by R. E. Dalton, Surveyor, dated February, 1916, recorded in the RMC Office for Greenville County, S. C., in Plat Book E, pages 114-115, and having according to said plat the following metes and bounds description, to wit:
