23. Waiver of Homestead. Borrower hereby waives all right of homestead exemption in the Property.

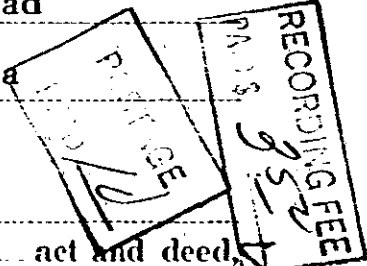

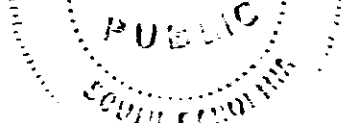
