COURSEON AS NOMINEE OF THE TRUSTEES OF MEDIAN MORTGAGE INVESTORS, A MASSACHUSETTS BUSINESS TRUST, AS BENEFICIARY, EUCODDED AUGUST 25, 1972 IN VOLUME 625, PAGE 436, IN THE OUTFICIAL PROOPDS OF SNOHOMISH COUNTY, WASHINGTON. SAID BENEFICIAL INTEREST WAS SUBSEQUENTLY ASSIGNED TO JACK R. COURSHON AS NOMINEE OF THE TRUSTEES OF FIRST MORTGAGE INVESTORS, A MASSACHUSETTS BUSINESS TRUST.

That portion of the Southeast One-Quarter of the Northeast One-Quarter of Section 29, Township 27 North, Range 4 East, W.M., Snohonish County, Washington, lying Southerly of 216th Street Southwest, Westerly of 60th Avenue West, Northwesterly of Primary State Highway No. 1, Northerly of 220th Street Southwest, and being more particularly described as follows:
