"All that certain piece, parcel or lot of land, with all improvements thereon, or bereafter constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, lying on the northern side of Edwards Road near the City of Greenville, being shown as Lot 37 on a plat of Botany Woods, Section 1 recorded in the RMC Office for Greenville County, South Carolina in Plat Book QQ at Page 78 and being more particularly described as follows:

BEGINNING at an iron pin on the northern side of Edwards Road at the front corner of Lot 38 and running thence with the line of said lot, N. 5-01 E. 185 feet to an iron pin; thence N. 11-58 W. 87.6 feet to an iron pin; thence S. 76-30 W. 110 feet to an iron pin at the rear corner of Lot 36; thence with the line of said lot, S. 9-55 W. 225 feet to an iron pin on the northern side of Edwards Road; thence with the northern side of Edwards Road, S. 79-20 E.
