All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 2 of property known as Sanders Knoll, property of Ben C. Sanders, according to a plat thereof prepared by C. O. Riddle, Surveyor, dated March 1972, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a nail and cap in the center of S. C. Highway No. 417 at the joint corner of Lots Nos. 2 and 3, and running thence with the joint line of said lots, S. 88-27 E. 253.6 feet to a point in the center of old Highway 417; and running thence with the center of said old road, N. 17-35 E. 200 feet to a point at the joint corner of Lots Nos. 1 and 2; and running thence with the joint line of said lots, N. 72-00 W. 283.7 feet to a point in the center of S.
