That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina. County of Greenville, Paris Mountain Township, located on the Eastern side of East Perry Road, and being shown as all of lot Number SIX (6) on a plat of property entitled "Leawood Hills", made for E. H. Batson and Homer Styles by Terry T. Dill, dated October 1958, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of said road at the joint front corner of lots 6 and 7 and running thence S. 46-38 E., 113.3 feet as the common line of said lots to an iron pin on the line of the Sunset Hills Subdivision; thence S. 43-30 W., 100 feet along the line of said subdivision to an iron pin at the joint rear corner of lots 5 and 6; thence N. 46-38 W., 113 feet as the common line of said lots to an iron pin on the southern side of said road, joint corner of lots 5 and 6; thence N. 43-22 E., 100 feet along the southern side of said road to the beginning corner. Bounded on the North by said road; on the East by Lot 7, of J. E. Davis, on the South by Sunset Hills Subdivision, on the West by Lot 5, of Sam Huff.
