All that certain tract of land, with the improvements thereon, situated in the County of Greenville, State of South Carolina, containing the area generally shown and described as follows, to-wit: the same, as shown on a plan of the property, recorded in the Office of the Clerk, on November 6, 1974, prepared by L. A. Gandy, Surveyor, Greenville, South Carolina, and certified to be a true copy of the same and measured and located as follows: Beginning at the Northwest corner of said tract where the same intersects the intersection of Green and Drayton Streets, the property bounded as Lowndes Hill Realty, Inc., to an iron; thence turning and running S 41° 17' W for a distance of One hundred and five-tenths (70.5') feet along the property line between Lowndes Hill Realty Co., and B. & B. Investments, Inc., in a group; thence turning and running N 69° 17' E for a distance of One hundred Fifty-nine and three-tenths (159.3') feet to an iron; thence turning and running S 73° 41' W for a distance of Three Hundred Twenty-six and two-tenths (302.2') feet along the property designated as Lowndes Hill Realty Co., and B. Investments, Inc. to an iron; thence turning and running N 3° 52' W for a distance of Fifty-five and four-tenths (55.4') feet along the right-of-way for Villa Drive; thence continuing N 44° 55' W for a distance of One hundred and forty-one-tenths (58.7') feet along the right-of-way for Villa Drive to an iron; thence turning and running N 23° 17' W for a distance of One hundred Nineteen and three-tenths (119.3') feet along the property designated as Kwind-Hung-Wilson Realty and Investments, Inc. to an iron; thence continuing along said property N 87° 0' W for a distance of One Hundred Five and two-tenths (105.2') feet to an iron; thence turning and running N 37° 10' E for a distance of Forty-seven (47') feet to an iron; thence turning and running S 87° 00' E for a distance of One hundred and sixty-one and four-tenths (260.8') feet to an iron; thence turning and running N 11° 05' W for a distance of One forty-nine and four-tenths (49.4') feet all along the property designated as Cemetery to an iron; thence turning and running N 37° 10' E for a distance of One Hundred Thirty and one-tenth (130.1') feet to an iron, thence continuing S 20° 11' W for a distance of One hundred and Ninety-five and one-tenth (195.1') feet to an iron; thence turning and running S 37° 20' E for a distance of One hundred and forty-five and six-tenths (145.6') feet to an iron; thence turning and running S 87° 0' W for a distance of One hundred and forty-five and six-tenths (145.6') feet all along the property line between the above and below described Drive to the iron at the point of beginning; the same being subject to a strip of land, one-half foot wide, reserved therefrom for a right-of-way for a driveway, and a one-half foot basement in the Southwest corner of the property, extending from property of Kwind-Hung-Wilson Realty and Investments, Inc. on the Westernmost boundary of the property, to the property of the City of Greenville, together with an easement for a driveway, one-half foot wide, running across the aforesaid property (50') from the property line.
