EDWARD H. HEMBREE BUILDERS, INC (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Fifty Thousand Four Hundred and no/100----- DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville shown as Lot 3 Bethel Road on plat of Bethel Heights recorded in the RMC Office for Greenville County in Plat Book 4R at page 72 and having the following courses and distances:

BEGINNING at an iron pin at the joint front corner of Lots 2 and 3 and running thence along the joint line of said lots, N. 28-13-01 W. 60.58 feet to an iron pin at the rear of Lot 3; thence along the rear of Lot 3, N. 62-12-00 E. 100 feet to an iron pin and N. 64-20-00 E. 24.03 feet to an iron pin at the joint corner of Lots 3 and 4; thence along the joint line of said lots, S. 26-46-40 E. 159.49 feet to an iron pin on Bethel Road, thence along Bethel Road, S. 62-06-00 W. 120 feet to the point of beginning.
