"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being known and designated as Lot 92 of Longforest Acres, Section Two, plat of which is recorded in the RMC Office for Greenville County in Plat Book 4F at Page II, and according to said plat, having the following metes and bounds, to-wit:
