All that piece, parcel or lot of land located in Greenville County, State of South Carolina on the south side of Howard Road and being shown as a 1.3 acre tract of land on a plat for James A. Howard, prepared by J. Q. Bruce, Surveyor, dated March 18, 1964, and recorded in Plat Book GGG at page 95 in the R.M.C. Office for Greenville County. References hereby made to said plat for a more complete description.

BUT ALSO: All that piece, parcel or lot of land in Greenville County, State of South Carolina, being shown as a .3 acre lot adjoining the above described property on a plat of property made for James A. Howard by W. N. Willis, Surveyors, dated September 21, 1970, and according to said plat having the following metes and bounds:

BEGINNING at a nail in the center of Howard Road at the corner of the 1.3 acre tract, and the corner of other property of James A.
