NOW, KNOW ALL MEN, that Mortgagor (or, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to the above named Mortgagee in the above Total of Payments and all future and other obligations of Mortgagor to Mortgagee, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all present and future improvements thereon situated in South Carolina, County of Greenville

All that piece, parcel or lot of land with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Highland Township, about one and one-half miles east from Pleasant Hill Baptist Church and being a portion of the property conveyed to L.W.Stringer, Verle Ferrer, Thomas P. Stringer and Stanley Stringer and Heyward Stringer in Deed Book 761, page 60 in the Register's Office for Greenville County and being described according to plat of property of Heyward P. Stringer prepared on January 13, 1969 and recorded in the said office in Plat Book 1-1, page 33 and according to said plat having the following metes and bounds, to-wit: Beginning at a nail in the center of a County paved road, which said point lies 610 feet from the L.W. If Mortgagor fails to make any of the above mentioned payments or fails to maintain satisfactory insurance, Mortgagee may, but is not obligated to, make such payments or effect insurance in Mortgagor's own name, and such payments and expenditures for insurance shall bear interest at the highest lawful rate if not prohibited by law, shall be a lien hereunder on the above described real estate, and may be enforced and collected in the same manner as the other debt hereby secured.



Upon any default, all obligations of Mortgagor to Mortgagee shall become due, at the option of Mortgagee, without notice or demand.


This mortgage shall extend, consolidate and renew any existing mortgage held by Mortgagee against Mortgagor on the above described real estate.
