NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 47 of a subdivision known as WHISPERING PINES as shown on plat prepared by F. E. Ragsdale, dated April, 1962, revised August, 1962, recorded in the R. M. C. Office for Greenville County in Plat Book PPP at page 65-A and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Edgewood Drive at the joint front corner of Lots Nos. 46 and 47 and running thence with said lots S. 60-00 E. 152.6 feet to an iron pin; thence with the line of property now or formerly of Jeckel N. 29-15 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 47 and 48; thence with the joint line of said lots N. 60-00 W. 151.3 feet to an iron pin on the southeastern side of Edgewood Drive; thence with the southereastern side of Edgewood Drive S. 60-00 W. 100 feet to the point of beginning.
