with interest thereon from date


at the rate of eight (Ser centum per annum, to be paid: annually

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being on the Southeast of the intersection of North Main Street and Garraux Street, (formerly known as Swiss Avenue), in the City of Greenville, and having according to a Survey made by Dalton, & Neves, Engineers, April, 1950, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Southeast corner of the intersection of North Main Street and Garraux Street, and running thence along the South side of Garraux Street, S. 66-10 E. 183.5 feet to an iron pin, corner of property now or formerly of Grace E. Phillips; thence with said Phillips line S. 20-57 W. 63.9 feet to an iron pin; thence along line of property of Hopkins and Rigas N. 71-20 W. 182.6 feet to an iron pin on the Southeast side of North main street; thence along Southeast side of North Main Street N. 20-10 E. 80 feet to the beginning corner.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
