

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Simpsonbille, being shown and designated as lot 33 on a plat entitled "Section 1, Powderhorn", dated July 26, 1973, revised March 1, 1974, prepared by Piedmont Engineers and Architects, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4X at page 95, and according to a revised plat of Lots 33, 34 and 35 by Robert P. Spearman recorded in Plat Book 5D at page 68 having the following metes and bounds, to-wit:
