SEND GREETING:

WHEREAS, I the said Harley A. McAbee

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Twenty Thousand and no/100 - - - - - (\$ 20,000.00 ) Dollars, with interest from the date hereof at the rate of nine per cent ( 9 % ) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor, in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Pre-ents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Pre-ents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S.
