NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, being known and designated as Lot No. 15 as shown on plat entitled "Property of Charles Watson and Mrs. Grace Watson Griffith" being recorded in the R. M. C. Office for Greenville County in Plat Book G, at Pages 164 and 165, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at a point on the east side of Watson Street, joint front corner of Lots 15 and 16; and running thence with the joint line of said lots, N. 70-44 E. 113.5 feet to an iron pin at the rear corner of Lot 2; thence with the line of said lot, N. 17-55 W. 50.15 feet to an iron pin at the corner of Lot 14; thence with the line of said lot, S. 70-53 W. 113.9 feet to an iron pin on the east side of Watson Street; thence with said street, S. 18-40 E. 50.5 feet to the beginning corner."

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free an i clear of all lives and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
