That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortgagor in hand well and truly paid by the Mortgager at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate.

All that certain piece, parcel, or lot of land with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that piece, parcel or lot of land situate, lying and being on the eastern side of Westover Place in the County of Greenville, State of South Carolina, and being more particularly described as Lot No. 41 as shown and designated on a plat of Section 2, Carter's Grove Subdivision, prepared by Dalton & Neves Co., dated August, 1974, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R, at Page 100, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Westover Place at the joint front corner of Lots 40 and 41 and running thence with the line of Lot 40 N. 70-28 E. 216 feet to an iron pin at the joint rear corner of Lots Nos. 40 & 41 in the line of property now or formerly of Waddell; thence with the line of property now or formerly of Waddell S. 9-30 W. 140 feet to an iron pin at the joint rear corner of Lots 41 and 42, thence with the line of Lot 42 S. 78-45 W. 164.4 feet to an iron pin on the eastern side of Westover Place; thence with the eastern side of Westover Place the following courses and distances: N. 2-37 W. 15 feet to an iron pin; N. 12-39 W. 85 feet to the point of beginning.
