

That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars \$5.00 to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Mauldin, and being known and designated as Lot No. 81 on plat of Forrester Woods, Section II, said plat being recorded in the RMC Office for Greenville County in Plat Book 4X, Page 64, and having, according to a more recent plat entitled "Property of John H. Emery and Josephine G. Emery" by Freeland & Associates dated March 21, 1975, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Creekwood Court at the joint front corner of Lots 80 and 81; running thence with the line of Lot 82 S. 13-36 W. 150 feet to an iron pin; thence N. 76-30 W. 110 feet to an iron pin at the joint rear corner of Lots 80 and 81; thence with the line of Lot 80 N. 13-36 E. 150 feet to an iron pin on the southern side of Creekwood Court; thence with the southern side of Creekwood Court S. 76-24 E. 110 feet to an iron pin, the point of beginning.

EMERY shall cease to be an employee of Bankers Trust of South Carolina, N.A., or a subsidiary, for any reason other than death, then, and in such event, the remaining principal balance secured by this mortgage, together with all accrued interest, shall at once become due and payable, at the option of the legal holder hereof.



Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner, it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, he considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that is is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the promises are free and clear of all hers and the umbanees except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the sail premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part the reof.
