That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars [\$3.60] to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon. situate, lying and being in the State of South Carolina, County of GRIZIVILLE, Chick Springs
Totalship, one-half rile north of the Town of Green, on the west side of Pine Street Extension, and being the same lot of land conveyed to T. J. Redd by J. 1. I con Cotober 2, 1930, and recorded in the R.H.C. Office for Greenville County in Deed Book 218, page 183, and having the following courses and distances, to-wit:

Extension (iron pin on west bank of street 15 feet from true corner) and runs thence N. 87-33 W. 115 feet to an iron pin on the Brannon line; thence N. 0-20 E. 70 feet to an iron pin; thence S. 87-33 B. 115 feet to a point in the center of said Pine Street Extension (iron pin on west bank of street); thence with the center of said street S. 0-20 W. 70 feet to the beginning corner, and containing 8030 square feet, core or less.
