That the Mortgager, in consideration of sud-delit and to secure the payment thereof and any further soms which may be advanced by the Mortgager to the Mortgager's account, and also in consideration of the sum of Three Dollars (5300) to the Mortgager in hand well and truly paid by the Mortgager at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, I argained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgager, its successors and assigns, the following described real estate.

All that certain piece, parcel, or lot of land with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot #97 on a Plat of Pine Brook Subdivision, Section I, prepared by Robert R. Spearman, R.L.S., dated March 15, 1972, recorded in the R.M.C. Office for Greenville County in Plat Book 4X at Pages 48 and 49, and having according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern edge of White Oak Drive, at the joint front corner of Lots #96 and #97, and running thence with the joint line of said Lots N. 16-35 W. 150 ft. to an iron pin; thence N. 73-25 E. 125 ft. to an iron pin at the joint rear corner of Lots #97 and #98; thence with the joint line of said Lots S. 16-35 E. 150 ft. to an iron pin on the Northern edge of White Oak Drive; thence with the edge of White Oak Drive S. 73-25 W. 125 ft. to an iron pin, being the point of Beginning.
