MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Donnie R. and DarleneR. Prickett

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Twenty Three Thousand

Seven Hundred and no/100----- (\$ 23,700.00---)

Dollars as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of One Hundred Ninety

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee ats successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of

All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, near Simpsonville, shown as Lot 42 on plat of West Georgia Heights recorded in Plat Book CCC at page 151 and having the following courses and distances:

BEGINNING at an iron pin on Blackhawk Drive at the joint front corner of Lots 42 and 43 and running thence along the line of Lots 42, 43 and 44, N. 66-08 E. 200 feet to an iron pin at the rear of Lots 42 and 44; thence along the rear line of Lot 42, S. 23-52 E. 100 feet to an iron pin at the joint rear line of Lots 41 and 42; thence along the common line of said lots, S. 49-28 W. 209.2 feet to an iron pin on BlackhawkDrive; thence along said Drive, N. 23-52 W. 106 feet to an iron pin, the point of beginning.
