MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

JACK W. JENKINS AND NETTIE JENKINS

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

NINETEEN THOUSAND, SEVEN HUNDRED AND NO/100

(\$ 19,700.00

Dollars as evidenced by Mortgagor's promissory note of even date herewith which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of One Hundred

Fifty Eight and 52/100 (5 158.52) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable

30 years after date, and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and impaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Templewood Drive, being known and designated as the major portion of Lot No. 52, of Section I, of OAK CREST, on a plat thereof made by C. C. Jones & Associates dated January 1955, revised August 1955, recorded in the R. M. C. Office for Greenville Countty, S. C. in Plat Book GG, pages 130 and 131, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Templewood Drive at the joint front corners of Lots Nos. 52 and 53, Section I, and running thence along the common line of said lot, S. 29-50 E., 150 feet to a point; thence along the rear lines of Lots Nos. 58 and 59, N. 60-02 E., 70 feet to a new point (said new point being 5 feet southwest from the joint rear corners of Lots Nos. 51 and 52); thence a new line through Lot No. 52, N. 29-58 W., 150 feet to a point on the southeastern side of Templewood Drive (said point being located 5 feet west of the joint front corners of Lots Nos. 51 and 52); thence along the southeastern side of Templewood Drive S. 60-02 W., 70 feet to the point of BEGINNING.
