NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, and being Lot #2 according to that plat of property of Grantee, prepared in July of 1967 by Dalton & Neves, Engineers, said plat being duly recorded in Plat Book 000, at Page 153, in the R. M. C. Office for Greenville County.

BEGINNING at an iron pin at the corner of lots nos. 2 & 3 and proceeding thence along the joint line between said lots S. 72-51 W. 538.6 feet to an iron pin; thence turning and proceeding S. 23-15 W. 180 feet to an iron pin; thence turning and proceedings S. 72-49 E. 541.5 feet to an iron pin; thence turning and proceeding N. 22-19 E. 180 feet to an iron pin, the point of beginning.
