

ALL that certain piece, parcel or lot of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that piece, parcel or lot of land situate, lying andbeing in Bates Township, Greenville County, South Carolina on the northern side of Second Street in the Town of Travelers Rest, being shown as Lot No. 57 on a plat recorded in the R.M.C. Office for Greenville County in plat book M, page 129, and having, according to said plat, the following metes and bounds, to wit:
