To Secure to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville South Carolina:

ALL that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Simpsonville, being shown and designated as Lot No. 27 on a plat entitled "The Cedars" (formerly "Castlewood") dated November 21, 1974, and recorded in Greenville County Plat Book 4 X at Page 93, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Tollgate Road at the joint front corner of Lots Nos. 27 and 28, and running thence along the rear lot lines of Lots Nos. 28 and 29, S. 70-11 W. 174.6 feet to an iron pin on the eastern side of Lot No. 30; thence continuing along the eastern side of Lot No. 30, S. 20-29 E. 45.0 feet to an iron pin on the rear of Lot No. 27; thence continuing along the rear of Lot No. 27, S. 9-57 W. 35.2 feet to an iron pin on the eastern side of Lot No. 22; thence continuing along the rear of Lot No. 23 and the northern side of Lot No. 26, N. 74-52 E. 184.8 feet to an iron pin at the joint front corner of Lots Nos. 26 and 27; thence continuing along Tollgate Road, N. 15-9 E. 91.0 feet to the beginning corner.

















To Have and to Hold unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate in the event this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands. subject to any easements and restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.

Uniform Covenants. Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest. Borrower shall promptly pay when due the principal of and interest on the indebtedness evidenced by the Note, prepayment and late charges as provided in the Note, and the principal of and interest on any Future Advances secured by this Mortgage.
