NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid dabt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 90 of WELLINGTON GREEN, SECTION 2, as shown on plat thereof recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book YY, at page 117, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Abingdon Way, which iron pin is the joint front corner of Lots Nos. 89 and 90, and running thence N 32-15 E 170.0 feet to an iron pin; thence S 57-45 E 100 feet to an iron pin; thence S 32-15 W 170.0 feet to an iron pin on the northeasterly side of Abingdon Way; thence along Abingdon Way, N 57-45 W 100 feet to the point of beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
