with interest from the date hereof at the rate of nine percent (9%) per annum unpaid interest to

bear interest at the same rate to be repaid in installments of One Hundred Ninety Seven and 94/100 -

----- \$ 197.94 Dollars

due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with the loan has been paid, and monthly payments to be applied first to the payment of interest, and then to the payment of principal, costs, expenses and insurance, if any, incurred, and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days or upon failure to comply with any of the by laws of said Association, or with any of the stipulations of the note, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, and said debt or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS That I the said Bennie F. Brown, Jr.

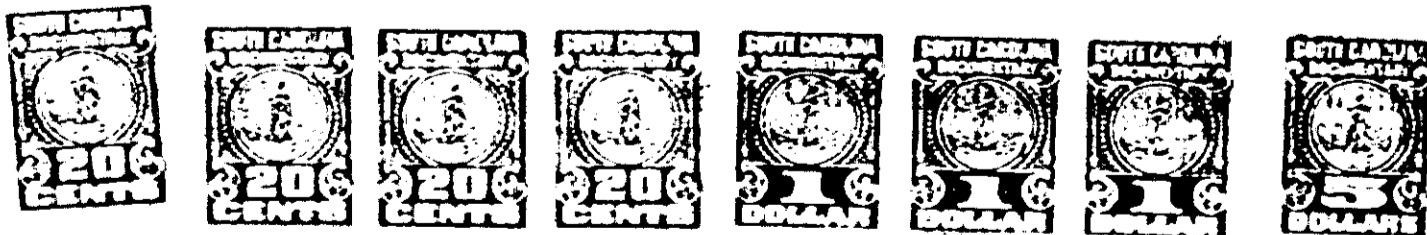
do hereby acknowledge the said debt and sums of money above said, and for the better securing the payment thereof to the said CITIZENS SAVING AND LOAN ASSOCIATION, Green S. C. according to the terms of the said note, and as a consideration of the further sum of Three (\$300) Dollars to the said note, I the said Bennie F. Brown, Jr. and well and truly paid by the said mortgage, at and before the sealing and delivery of these Presents, a sum of Three (\$300) Dollars which is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do hereby sell and release unto the said CITIZENS SAVING AND LOAN ASSOCIATION, Green S. C. its successors and assigns

That certain lot, parcel or tract of land with all improvements now constructed thereon, or hereafter constructed thereon, situated, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, lying on the north side of County Road known as Chick Springs Road, being cut out of the southwest corner of the property conveyed to Bennie F. Brown, Sr. by deed recorded in the R. M. C. Office for Greenville County in Deed Book 906 at page 289, and having the following courses and distances:

Beginning at a point in the center of the said Chick Springs Road, joint corner of property of Deveor, and runs thence with the common line of the said parties, N. 2-00 W. 20 feet to an iron pin on the north side of the said road, then continuing the said common line, for a total distance of 217 feet to an iron pin on the said line; thence a new line, N. 89-30 E. 110 feet to an iron pin; thence S. 9-45 E. 184.4 feet to a point in the center of the said road; iron pin back on line at 23 feet; thence with the center of the said road, S. 67-15 W. 141.6 feet to the beginning point.
