on or before the time of the execution of this instrument the M. may at any time require the sum of \$5,000.00 or less than \$5,000.00 plus interest at the rate of 7% per annum, which amount shall be paid to the M. or to the credit of the M. in the County of Greenville, State of South Carolina. The M. may require the payment of the principal and interest in installments if the M. so directs, and the M. may require the payment in full of the principal and interest in one sum. The M. may require payment of interest at any time after the date of the maturity of the principal.

If the M. at any time before the time of the maturity of the principal demands payment of all or any part of the principal and interest in advance of the date of the maturity of the principal, the M. may demand payment of interest at a rate which is higher than the rate which would otherwise have been payable from the date of the maturity of the principal to the date of the payment of the principal. The M. may charge a late fee if payment is made after the time specified by the M. or before the M. may require payment of the principal and interest. The M. may require the payment of costs and expenses which may be incurred by the M. in collecting the principal and interest. The M. may require the payment of costs and expenses in connection with the collection of the principal and interest.

The debts, interest, and expenses shall be paid to the respective parties, administrators, and assigns of the parties to the M. When the M. has collected the principal and interest, the M. shall thereafter demand payment of costs and expenses in connection with the collection of the principal and interest.
