TO ALL WHOM THESE PRESENTS MAY CONCERN: JOHN P. & FRANCES E. UNDERWOOD

(hereinafter referred to as Mortgagor) SEND(\$) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

SEVENTEEN THOUSAND FIVE HUNDRED and no/100 ----- IXXII.ARS

(\$ 17,500.00). As evidenced by the Mortgagor's note of even date, hearing interest as stated in said note, and payable as therein stated or as in elified by normal agreement, in writing, the final maturity of which is twenty-five—years after the date hereof unless extended by mutual consent, the terms of said note and any agreement modifying it are accorporated berein by reference, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Didlars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell, and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as Lot No. 73 Brantford Lane on Plat of SOUTH FOREST ESTATES prepared by Pickell & Pickell, Engineers, dated August 29, 1955, recorded in the RMC Office for Greenville County in Plat Book "GG", at Page 181, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Brantoford Lane at the joint front corner of Lots Nos. 73 and 74 and running thence with the common line of said Lots S. 66-34 W. 130 feet to an iron pin; thence N. 20-55 W. 65.3 feet to an iron pin; thence N. 7-54 W. 59.5 feet to an iron pin at the joint rear corner of Lots Nos. 72 and 73; thence running with the common line of said Lots N. 84-41 W. 122.2 feet to an iron pin on the Western side of Brantoford Lane; thence running with the Western side of Brantford Lane S. 14-15 E., 31.6 feet; thence continuing with Brantford Land S. 23-26 E. 53.4 feet to the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagors promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on their failure to pay it, the mortgagee may advance it for the mortgagors' amount and collect it as part of the debt secured by the mortgage.

The Mortgagors agree to maintain guaranty insurance in force until the loan balance reaches 75% or less of the original appraisal or sales price, whichever is less, and the mortgagee may apply for mortgage guaranty insurance to comply with the above, through the mortgage guaranty insurance company insuring this loan, and that the mortgagors agree to pay to the mortgagee, annually, as premium for such insurance 1/4 of 1% of the principal balance then existing.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fix tures and equipment, other than the usual household furniture, be considered a part of the real estate
